1. What Data do We Collect About You?

System update

We shall collect and process your following data:

- Device information

Including the serial number (S/N), device model, software version number

To provide you with the services, this device needs to access the Internet, and query and download update packages. During this process, mobile data usage may occur.

2. How do We Use Your Data?

To provide you with the services you have subscribed to, and fulfill contractual obligations, MeiG Smart Technology will use and process your personal data. The data is processed in order to analyze and update your operating system and improve our products (or services).

Your personal data collected by the system update services will be retained for fifteen (15) days.
